For Upcoming Events, Staff/volunteers will get entire statement from the Guild. Group will receive the edited version below:

Effective December 1, 2015, Handbell Musicians of America requires adherence to and implementation of our <u>Youth Protection Policy</u> for all Sponsored and Endorsed events involving youth under the age of 18.

This policy was developed with the guidance of the Stewards of Children program which teaches adults how to prevent, recognize and react responsibly to child sexual abuse. The goal of this policy is to create a safe and secure environment at our events for all who attend

  - b. Teachers and clinicians receive free food and free registration
  - c. Room setup and behind the scene volunteers receive free registration
- 3) We need to provide a consistent policy of discounts.

#### B. Vendors

- 1) Florida never charges a fee to vendors.
- 2) Handbell Services and The Raleigh Ringers both give 20% of their sales back to the Area.
- 3) Jeffers Handbell Supply does not pay a percentage to Florida when they provide staff to sell music on site. At the Georgia Spring Ring, GA receives a percentage of sales from Jeffers because they do not send a representative to sell music.

- C. Motion that Area 4 covers expenses for Alan Lohr to attend the LowCountry Handbell Festival in SC not to exceed \$300 by Sally Traylor. William Murphy second. Unanimously approved.

- C. Lynne Homan suggests a PowerPoint slide show during registration at events.

- E. Donna Bradham requesting all flyers that were created for events and event programs be submitted.

- Event coordinators must see that the guidelines are carried out.

#### Directors and Officers Insurance (D&O Insurance)

When National recnetly updated their insurance coverage, it was discovered that the Area Directors and Officers and not covered under the National Policy. D&O Insurance covers the organization (Area 4) and its directors (us) again actual or alleged wrongful acts in three major areas:

- a. Goverance liability claims resulting from general goverance decisions;
- b. Fiduciary liability: claims resulting from alleged fraud and improper financial oversight
- c. Employment practices liability: claims resulting from employment-related activities

I am in conversation with the company insuring National and an additional company to secure quotes. The information will be shared with the Executive Committee and we will make a recommendation to the Board. Let me know if you would like more details.

Updates to Area 4 Rules of Procedure

The proposed updates to the Area 4 Rules of Procedure are in the Board notebook and will be reviewed during this meeting. Additional comments should be directed to me so I can distribute the final updates for an electronic vote by January 30, 2016.

Repertoire Selection Policy

A copy of the Repertoire Selection Guide is in the meeting notebook. All sponsored events must follow these guidelines, send the suggested rep list to the Executive Board for approval, and attach a copy of the approved list to the application for sponsorship.

Borrowed Equipment Form

A copy of the borrowed equipment form is in the meeting notebook and can be found in the Board Members area of the Area 4 website (area4.handbellmusicians.org). Use this form for <u>all</u> equipment borrowed for events, secure signatures upon pick up and delivery from representative of loaning organization.
