

Area 4 American Guild of English Handbell Ringers Performance Agreement

This Agreement, made and entered into by and between **Area 4 of the American Guild of English Handbell Ringers, Inc.**, hereinafter referred to as "Area 4 AGEHR" and **{INSERT GROUP NAME HERE}**, hereinafter referred to as "Performer"

WITNESSETH WHEREAS AREA 4 AGEHR desires the services of Performer to present a concert on **{INSERT DATE AND TIME HERE}**, hereinafter referred to as "Performance"; and

WHEREAS, the Performer is uniquely qualified to provide such services; and

WHEREAS, such services are professional and non-competitive in nature,

NOW; THEREFORE it is mutually agreed to as follows:

Section 1. Scope of Services

The Performer agrees to the following:

- a. Performer shall present a concert of approximately 60 minutes in length.
- b. The Performance shall take place at **{INSERT VENUE NAME HERE}**, hereinafter referred to as "Venue".
- c. Performer shall provide AREA 4 AGEHR with photos and biographical information for use in publicizing and advertising Performance no later than **{INSERT DATE}**
- d. Performer shall provide AREA 4 AGEHR with a list of songs that will be played during the Performance no later than **{INSERT DATE}**, for inclusion in the Event program guide.
- e. Performer shall provide all equipment required for this performance unless otherwise specifically agreed to in writing. AREA 4 AGEHR shall provide a stage for the performance, bare 6' x 30" tables in a number to be mutually agreed upon, and one microphone for stage announcements. Performer shall provide AREA 4 AGEHR with a stage diagram and space requirements no later than **{INSERT DATE}**. If Performer would like AREA 4 AGEHR to provide additional equipment, Performer must provide one complete and detailed list of the equipment requested by **{INSERT DATE}**. AREA 4 AGEHR shall have no obligation to provide such equipment and retains the option to not provide requested equipment if doing so will result in undo financial hardship for AREA 4 AGEHR.

Section 2. Compensation and Method of Payment

- a. **Compensation**
AREA 4 AGEHR agrees to pay the Performer **{INSERT AMOUNT}** honorarium.
- b. **Method of Payment**
Honorarium will be paid in the form of an AREA 4 AGEHR check to the Performer upon the completion of services as required under the terms of this agreement.

Section 3. Term

The term of this Agreement shall begin on the date of the execution of this Agreement, and shall end upon completion of all obligations contained herein.

Section 4. Termination

The Agreement may be terminated by AREA 4 AGEHR or PERFORMER at any time by giving thirty (30) days written notice to the other party.

Section 5. Hold Harmless

The Performer shall protect and hold the American Guild of English Handbell Ringers, Inc. its officers, directors, employees, subcontractors, and volunteers harmless from any and all loss, claims, expenses, actions, causes of action, cost damages, and obligations, financial and otherwise, arising from any and all acts of the Performer that result in copyright infringement and injuries to persons or damage to property. The Performer is not an employee of the American Guild of English Handbell Ringers, Inc. The Performer is an independent contractor and shall be responsible for his/her own tax withholding and Workers' Compensation and the Workers' Compensation of his/her employees.

Section 6. Additional Terms and Conditions

If additional terms and conditions are attached hereto, and by this reference made a part hereof, any such additional terms and conditions in conflict with Sections One (1) through Five (5) above shall be void and unenforceable.

IN WITNESS THEREOF, Area 4 American Guild of English Handbell Ringers, Inc., and the Performer agree to the terms, arrangements, and responsibilities as stated above.
